Privacy Policy

Privacy

This website offered by Carelon Behavioral Health, Inc. ("Carelon Behavioral Health site") is designed to help you learn more about getting help with life issues that are sensitive, emotional, and often private. We respect your personal privacy and provide this informational statement so that you may better understand how we may collect and use aggregate and personal information about you. This privacy statement ("Privacy Statement") describes Carelon Behavioral Health privacy and security practices for this website. Except where noted, statements in this privacy policy with respect to the Carelon Behavioral Health site also apply to Carelon Behavioral Health applications ("App") available for mobile devices, including but not limited to iPhones, iPads, Androids and/or other smart devices.

Your acceptance of these terms

By using this site, you signify your acceptance of the terms of the Carelon Behavioral Health Privacy Statement. If you do not agree to the terms of this Privacy Statement, please do not use the Carelon Behavioral Health site and exit the site immediately. Your continued use of the Carelon Behavioral Health site following the posting of changes to these terms will mean that you accept those changes.

Your Internet Protocol (IP) address

For each visitor to the Carelon Behavioral Health site, Carelon Behavioral Health servers automatically collect information about which pages are visited and the IP address or domain name (e.g., carelonbehavioralhealth.com) of visitors. We use your IP address to help diagnose problems with our server and to administer our website. Your IP address is used to help identify you and to gather general demographic information.

Cookies

Carelon Behavioral Health may place a "cookie" on the browser of your computer. Cookies are pieces of information that a website transfers to your computer's hard disk for record-keeping purposes. The use of cookies is common in the internet industry, and many major websites use them to provide useful features to their customers. The cookie itself does not contain any personally identifying information, but may be used to tell when your computer has contacted the Carelon Behavioral Health site. Carelon Behavioral Health uses the information for editorial purposes and for other purposes, such as delivery of features and advertisements, so that Carelon Behavioral Health can customize delivery of information specific to your interests without compromising privacy. Disclosing information

The aggregate information we share with our business partners is not linked to any of your personally identifiable information. For example, Carelon Behavioral Health may provide information to third parties about how many people use our website, what features of the website they use, and how many users of the website live in certain ZIP codes. Carelon Behavioral Health may disclose account information in special cases (i) to comply with valid legal requirements, such as a law, regulation, search warrant, subpoena, or court order; or (ii) when Carelon Behavioral Health has reason to believe that disclosing this information is necessary to identify, contact or bring legal action against someone who, intentionally or unintentionally, may be causing injury or harm to Carelon Behavioral Health users or other persons or violating the terms and conditions of this site.

In the event that Carelon Behavioral Health or any component of Carelon Behavioral Health's operations is merged with or is acquired by another entity, then any such successor or acquiring entity may become the successor to our obligations with respect to the personal information that you have provided to Carelon Behavioral Health, which would be necessary for the entity to effectively continue Carelon Behavioral Healths' business. By using the Carelon Behavioral Health site, you consent to any such use of your personal information by such an entity assuming control of Carelon Behavioral Health's operations as a result of a merger, a purchase of Carelon Behavioral Health assets, or a liquidation of Carelon Behavioral Health in bankruptcy or insolvency.

Security

This site has security measures in place to protect against the loss, misuse, and alteration of the information under our control.

Mobile device applications

When you download and install one of our Apps onto your mobile device, we assign a random number to your App installation. This number cannot be used to identify you personally, and we cannot identify you personally unless you choose to become a registered user of the App. We use this random number in a manner similar to our use of cookies as described in this privacy policy. Unlike cookies, the random number is assigned to your installation of the App itself and not a browser, because the App does not work through your browser. Therefore, the random number cannot be removed through settings. If you do not want us to use the random number for the purposes for which we use cookies, please do not use the App, and please use your mobile device browser to access the Carelon Behavioral Health site or our mobile-optimized sites. We do not obtain any information about your mobile device, other than the brand, make, model, and type of operating software your device uses. Please note that certain Apps require registration either to use the App or to use certain functionality in the App. Carelon Behavioral Health's Apps obtain your consent (via an opt-in) before using information from pinpointing technology like Global Positioning System (GPS) or cell tower information. You can withdraw your consent (via an opt-out) for the use of your location by Carelon Behavioral Health at any time by changing your location services in the "Settings" function on your mobile
